RE: Resolution re-authorizing the Juvenile Justice Coordinating Council through June 30, 2007

Dear Board Members:

On April 17, 2001 your Board approved the Probation Department's submission of the County's Multi-Agency Juvenile Justice Plan and Funding Application to the State Board of Corrections (BOC) for the Juvenile Justice Crime Prevention Act (JJCPA) program. The State Board of Corrections is now known as the Corrections Standards Authority (CSA). The funding application was approved by the CSA on April 23, 2001, and the funds in the amount of \$935,737 were included in the supplemental budget for FY 2001-02. For the FY 2002-03, the CSA provided information regarding changes as a result of SB 736 which require the local Juvenile Justice Coordinating Council to review and modify its comprehensive plan annually, and for the County Board of Supervisors and Corrections Standards Authority to approve the modified plan.

On April 26th, 2005 your Board approved the Probation Department's submission of the County's fifth year Multi-Agency Juvenile Justice Plan and funding application to the CSA for the JJCPA program. JJCPA funding has decreased each year from first year funding of \$935,737 to \$718,040 for FY 2005-06. Funding for FY 2006-07 is to remain at \$718,040.


As a result of SB 763, the County will need to reconvene the Juvenile Justice Coordinating Council to review and agree that the programs in the existing plan are viable, review potential budget changes, and secure a required Board of Supervisors resolution approving the program modifications.

The attached resolution identifies the proposed members of the JJCC, updated due to various personnel changes. The Probation Department will be convening the JJCC in April 2006 to review and update the County's Multi-Agency Juvenile Justice Plan and Funding Application, and will return to your Board for final approval to submit the modification to the Corrections Standards Authority no later than May 1,2006.

IT IS THEREFORE RECOMENDED that your Board:

1. Adopt the attached resolution approving the membership and re-authorizing the Santa Cruz County Juvenile Justice Coordinating Council through June 30,2007; and
2. Direct the Probation Department to return to your Board on or before April 25, 2006 with a report on the revisions to the Multi-Agency Juvenile Justice Plan and Funding Application for the Board of Corrections Juvenile Justice Crime Prevention Act Program.


