## STATUS REPORT ON SONIC TRANSFERS

Dear Supervisors:

On April 14, 1998, your Board directed that this **office** report on April 21, 1998 on the two transfers of ownership involved in the sale of Sonic Cable TV to Charter Communications Properties, LLC ("Charter"). On April 15, 1998, Sonic and Charter consented to extend the time for review of the transfers until April 28, 1998 and on April 22, 1998 Sonic and Charter consented to extend the time for review until May 5, 1998. Sonic and Charter have now consented to extend the review period until May 19, 1998 and have also agreed not to attempt to close the acquisition around Santa Cruz.

It is therefore RECOMMENDED that your Board accept and file this status report and schedule consideration of the County Administrative Officer's Report on the Sonic Transfers for May 19, 1998.
