UNIVERSITY OF CALIFORNIA, DAVIS TRAINING CONTRACT AMENDMENT

Dear Members of the Board:

Your Board previously took action at your November 18, 1997 meeting to approve the Human Resources Agency (HRA) annual contract with the University of California, Davis (UC Davis) to provide staff development training under the California Department of Social Services (CDSS) staff development training program. The contracted training in the amount of \$37,800 was financed through a combination of federal Title IV-A funds awarded to CDSS and in-kind match from UC Davis.

HRA is requesting a contract amendment to include four additional days of training for HRA staff, increasing the contract amount to \$48,600. Expenditures for the contract amendment are included in HRA's 1997/98 budget and represent no County cost. HRA is requesting your Board's approval of the attached amended agreement with UC Davis to provide these additional training days.

IT IS THEREFORE RECOMMENDED that your Board authorize the Human Resources Agency Administrator to sign the amended agreement with the University of California, Davis to provide training for Human Resources Agency staff.


