Attachment to Application for Appointment to the SANTA CRUZ COUNTY FIRE DEPARTMENT ADVISORY COMMISSION

I am interested in serving on the Fire Department Advisory Commission because the quality of fire protection and emergency medical services is extremely important to any community, particularly the rural ones where distances cause delays. I have had the opportunity and the need to increase my understanding of the County Fire Department and the role of the volunteer companies within it during the past eight years while serving as a Director of Bonny Doon Volunteer Fire's non-profit corporation.
