JOB TRAINING PARTNERSHIP ACT (JTPA) PROCUREMENT FOR SUMMER YOUTH EMPLOYMENT AND TRAINING AND ADULT PROGRAMS

Dear Members of the Board:

As your Board is aware, the Human Resources Agency's CareerWorks Division conducts periodic procurements to solicit qualified bidders to provide JTPA funded services. Recently, CareerWorks conducted two procurements: Summer Youth Employment and Training Program (SYETP) Academic Enrichment and Adult On the Job Training (OJT) services. CareerWorks is requesting authorization to enter into negotiations for the contracts which will be brought to your Board for approval. These JTPA contracts are fully federally funded and will represent no cost to the county.

The two procurements were conducted according to JTPA regulations for free and open competition. After public notification of the Request for Qualifications (RFQ)/Request for Proposals (RFP) was issued, the RFP was mailed to interested parties and a bidder's conference was held. Submitted proposals were then reviewed by two proposal review teams according to the criteria developed specific to the service.

SYETP provides academic enrichment services during the summer to complement youths work experience activities. The Adult OJT services contract will fund fiscal year 1998-99 brokered job training at the employer's worksite for economically disadvantaged adults and dislocated workers.

The following staff recommendations for funding were approved by the Private Industry Council (PIC) Evaluation and Planning Subcommittees:
