
Included in the 1997/198 Redevelopment Agency, Public Works and Zone 5 budgets are funds for the construction of the subject roadway, roadside, drainage, water supply, restroom, parking lot, and landscape improvements.

The plans, specifications and estimate have been completed for the subject project, and are presented here for your consideration and approval. The total engineer's estimate for this project is \$858,600.00 including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and Engineer's Estimate and authorize calling for bids.
2. Set bid opening for 10:45 a.m. on June 9, 1998.
3. Direct the Clerk of the Board to advertise a "Notice to Contractors" for a 10-day period beginning May 23, 1998, in accordance with the provisions of Public Contract Code Section 20392.


Bids are required for the entire work.
