

BID AWARD - JOSE AVENUE IMPROVEMENTS SUBJECT:

CAPITOLA ROAD TO RODRIGUEZ STREET

Members of the Board:

The Board of Supervisors received six bids for the subject project on May 5, 1998, which have been checked by the Department of Public Works and found to be in order. The low bid was submitted by Bugler Construction of Fremont in the amount of \$167,163.50. The engineer's estimate was \$183,860.00.

Sufficient funds are available for this work in the 1997/98 Public Works Road Program and Redevelopment Agency budgets. The construction of this project is funded partly by Redevelopment funds. Redevelopment funds are being used because it has been determined that the improvements are of benefit to the project area or the immediate neighborhood in which the project is located, that no other reasonable means of financing the improvements are available to the community, that construction of the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's five year implementation plan.

The Redevelopment Department has a letter to the Board of Directors of the Redevelopment Agency on today's agenda approving the expenditure of funds necessary for this contract.

This project was originally planned to be a sidewalk infill project, funded by the Redevelopment Agency. However, the condition of the Jose Avenue pavement is extremely poor. The project as bid includes the complete removal and reconstruction of the existing street section. It is proposed that the street reconstruction be paid for by funds received from the State-Local Transportation Partnership Program this fiscal year. In order for these funds, in the amount of \$75,000, to be made available, it is necessary for your Board to adopt the attached resolution accepting unanticipated revenue.

It is recommended that the Board of Supervisors take the following action:

- 1. Make findings that the improvements are of benefit to the project area or the immediate neighborhood in which the project is located, that no other reasonable means of financing the improvements are available to the community, that construction of the project will assist in the elimination of blight, and that the project is consistent with the Redevelopment Agency's five year implementation plan.
- 2. Adopt resolution accepting unanticipated revenue in the amount of \$75,000.00.
- 3. Accept the low bid of Bugler Construction, in the amount of \$167,163.50.00, and authorize the award of the contract.
- 4. Authorize the Director of Public Works to sign the contract on behalf of the County of Santa Cruz.
