SUBJECT: GREEN VALLEY ROAD STORM DAMAGE REPAIR PROJECTS,
P.M. 8.0, OES # 048 & P.M. 6.2, DSR # 95056

Members of the Board:

The plans, specifications, and engineer's estimate for the subject combined projects are now complete and presented here for your consideration and approval. The work provides for the repair of two storm damage sites on Green Valley Road, which occurred in 1996 and 1997 respectively. These projects will provide for construction of rock slope protection on the road embankment and repair of the damaged portions of the road pavement at both locations.

The engineer's estimate for this work is \$124500.00, including contingencies and overhead. Sufficient funding for these projects was included in the approved 1997/98 Road Program and included funding from the Federal Emergency Management Agency (FEMA) for P.M. 6.2, DSR No. 95056, and the State Office of Emergency Services (OES) for P.M. 8.0, OES No. 048.

It is therefore recommended that the Board of Supervisors take the following action:


1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 A.M. on June 9, 1998.



No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class 'A' license at the time this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
