SUBJECT: JAMISON CREEK ROAD 1998 STORM DAMAGE REPAIR PROJECT  
AT P.M. 1.63, EMERGENCY RELIEF DAMAGE ASSESSMENT FORMS  
CSC-SCR-003E

Members of the Board:

The plans, specifications, and engineer's estimate for the subject emergency relief project are now complete and presented here for your consideration and approval. The repair work, as approved by the California Department of Transportation (CALTRANS) under the subject Damage Assessment Forms (DAFs), allows for the repair of a **slipout** on Jamison Creek Road, which resulted from the February 1998 storms. This project will provide for construction of cribwall, **overside drain**, guardrail, and erosion control.

The engineer's estimate for this work is \$193,044, including contingencies and overhead. Funding for this project has been made available through the Federal Highway Administration's "On System" road storm repair program which is administered by CALTRANS. This program is funded at a 100 percent reimbursement for all work completed during the first 180 days of the event until August 1, 1998, excluding the County's administration expenses. After August 1, 1998, the rate of reimbursement is reduced to 88.53 percent. Funds for the local share of these expenses are made available from other Road Budget programs (estimated at approximately \$15,000).

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate, and authorize calling for bids.

- 2. Set the bid opening for 10:45 A.M. on June 9, 1998.
- 3. Direct the Clerk of the Board to advertise a notice to contractors for a ten-day period beginning May 24, 1998, in accordance with the provisions of Public Contract Code Section-20392.

This project involves the construction of a concrete cribwall, underdrain system, regrading slopes, roadway repair, rock slope protection and providing erosion control at the two subject locations.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation's publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
