SUBJECT: 1998/99 COUNTY SERVICE AREA NO. 5, SAND DOLLAR BEACH FEES  
(2ND DISTRICT)

Members of the Board:

Public Works has received a letter from the Sand Dollar Beach, County Service Area (CSA) No. 5 representative requesting an increase in rates for the 1998/99 fiscal year. The proposed increase is needed in order to repay a \$14,500 beach stairway construction loan, and to bank monies toward repair of a second beach stairway.

As CSA No. 5 fees are considered a property related charge, any increase in rates will have to comply with Proposition 218 procedures. These procedures require that a public hearing be held to hear and consider any protests on the proposed increase. Furthermore, 45 days prior to the public hearing, a notice must be mailed to each property owner within CSA No. 5. This notice must state the amount of the proposed increased charge, the reason for the charge and the date, time and location of the public hearing (Attachment "A"). Lastly, the public hearing must be advertised at least 45 days prior to the public hearing in a newspaper of general circulation (Attachment "B").

Once the 1998/99 rate has been established and approved by your Board, a second public hearing will be advertised (Attachment "C") and held, this time to consider and confirm a service charge report. The service charge report will be on file with the Clerk of the Board of Supervisors for public review two weeks prior to the second public hearing. As provided in Chapter 4.26 of the County Code, the service charge report must be approved by your Board and forwarded to the Auditor-Controller by August 10, 1998.

It is therefore recommended that the Board of Supervisors take the following action:


1. Adopt the attached resolution setting Tuesday, April 14, 1998, during the morning agenda (which begins at 9:00 a.m.), as the date and time for a public hearing on CSA No. 5, Sand Dollar Beach rates and direct the Clerk of the Board to publish the attached notice of public hearing once 45 days prior to the hearing and then again once a week for two weeks prior to the hearing in a newspaper of general circulation.

2. Approve the attached notice of public hearing on the proposed 1998/99 property related charge for CSA No. 5, Sand Dollar Beach zone and direct the Department of Public Works to mail out the notice to all affected property owners within CSA No. 5, Sand Dollar Beach at least 45 days prior to the April 14, 1998, public hearing.
3. Adopt the attached resolution setting Tuesday, June 2, 1998, during the morning agenda (which begins at 9:00 a.m.) as the date and time for a public hearing on CSA No. 5, Sand Dollar Beach service charge report and direct the Clerk of the Board to publish the attached notice of public hearing once a week for two weeks prior to the hearing in a newspaper of general circulation.


