16	3. This claim is based on a personal injury to claimant
17	which occurred on December 11, 1997 at about <b>7pm,</b> near 257
18	Center in Aptos, Santa Cruz County under the following

20	Claimant Rivard had exited Kim's on Center and she was
21	walking toward her car. She stepped off the sidewalk curb and
22	she tripped over a tire berm that was in front of the curb. It
23	was dark, so Mrs. Rivard did not see the berm. She did not
24	anticipate a tire berm, since the sidewalk had a curb.
25	The County of Santa Cruz knew or should have known that this
2,6	was a dangerous condition. They knew or should have known that
27	people walking to their cars from the sidewalk in the dark would
28	be able to see a tire berm, nor would they expect there to be a

57 tire berm when there is a sidewalk with a curb. 1 But for the County's negligence in failing to remove these 2 tire berms before Mrs. Rivard's fall, Mrs. Rivard would not have 3 been injured. 4 4. Claimant does not know the name of the public employee 5 who caused claimant's injury. 6 5. The injury sustained by claimant consists of a broken 7 wrist, broken ribs, chipped teeth, a split chin and a split lip 8 and an injury to the back. She is receiving medical treatment 9 for these injuries. 10 6.
