RE: RECOMMENDATION FOR AWARD FOR EMERGENCY POWER UPGRADE AT PROBATION CENTER/JUVENILE HALL & JAIL #97C1-015

Members of the Board:

At the May 19, 1998 Board meeting, bids were received for the Emergency Power Upgrade at Probation Center/Juvenile Hall & Jail project. Your Board directed the General Services Department to review bids and return on or before June 23, 1998 with a recommendation for award.

As directed, bids received have been reviewed and we believe that the lowest bidder, Steve Lacki Electrical Construction with a bid of \$111,387, can accomplish the work to the County's satisfaction.

Sufficient funds are available in the Plant budget, index 194020, subobject 6610 including a ten (10) per cent contingency.

It is therefore RECOMMENDED that your Board:

- 1. Award a'contract to Steve Lacki Electrical Construction for \$111, 387; and
- 2. Direct General Services to notify the Contractor and arrange for completion of contract documents; and
- 3. Authorize the Director of General Services to approve change orders, if required, up to \$11,114; and

- 4. Appropriate \$11,114 in addition to the contract amount to cover change order expenditures, if required; and
