Members of the Board:

At the May 19, 1998 Board neeting, bids were received for the Sheriff's Records Area HVAC Upgrade project. Your Board directed the General Services Department to review bids and return on or before June 23, 1998 with a recommendation for award.

As directed, bids received have been reviewed and we believe that the lowest bidder, Geo. H. Wilson, Inc. with a bid of \$103,500, can accomplish the work to the County's satisfaction.

Sufficient funds are available in the Plant budget, index 191050, subobject 6610 including a ten (10) per cent contingency.

It is therefore RECOMMENDED that your Board:

- 1. Award a contract to Geo. H. Wilson, Inc. for \$103,500; and
- 2. Direct General Services to notify the Contractor and arrange for completion of contract documents; and
- 3. Authorize the Director of General Services to approve change orders, if required, up to \$10,350; and
