Dear Members of the Board:

Maria Silvia Pintor aka Silvia Pintor obtained a welfare overpayment from the Santa Cruz County Human Resources Agency for Aid to Families with Dependent Children (AFDC) in the amount of \$11,798.00.

This overpayment occurred during the period of August 199 1 through November 1994 when Ms. Pintor failed to report the correct household composition of all income.

Ms. Pintor has been notified of our intent to commence suit. She has made no effort to clear her account and avoid the additional costs of legal action.

Therefore, it is recommended that your Board pass and adopt the attached resolution authorizing County Counsel to commence civil suit for restitution.
