Re: ACCEPT UNANTICIPATED REVENUES

Dear Members of the Board,

During the June 1997-l 998 budget hearings the Elections Department's proposed budget only included the costs of the June 1998 primary. The November 1997and April 1998 Special Elections were not scheduled until after budget hearings. Although the schools and the City of Scotts Valley are paying for the costs of the two special elections, additional funds must be appropriated in the Election Department budget.

The Special School District election held on April 14, 1998, and the City of Scotts Valley Bond Measure held on November 4, 1997 increased the department's service and supply costs by \$45,000, and extra help charges by \$58,000. The schools and city were billed and have paid these costs, resulting in unanticipated revenues.

It is therefore RECOMMENDED your Board adopt the attached resolution accepting and appropriating unanticipated revenues in the amount of \$103,000 from schools and the City of Scotts Valley as reimbursement for the costs incurred while conducting their elections.
