Members of the Board:

The Board of Supervisors received two bids for the subject project on June 9, 1998, which have been checked by the Department of Public Works and found to be in order. The engineer's estimate for this work was \$177,584. The low bid was submitted by Bugler Construction Incorporated of Fremont in the amount of \$196,940.00.


Funding for the subject project is provided by the approved 1997/98 Public Works Road Budget by using funding appropriated from program surplus funds (estimated local share at \$16,000) and a Damage Assessment Form, DAF, No. CSC-SCR-003E, which was written by the Federal Highway Administration (FHWA) for work on "On-System" roads.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Bugler Construction Incorporated in the amount of \$196,940.00 and authorize award of the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the county.

- 3. Adopt the attached resolution accepting unanticipated revenue in the amount of \$230,000.00 from the California Department of Transportation and appropriate these funds into the 1997198 Public Works Road Program Budget.




