The plans, specifications and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for a 2 inch overlay of Muir Drive in County Service Area No. 26, Hidden Valley Road.

The engineer's estimate for this work is \$33,437.50 including contingencies and overhead. Sufficient funding for this project is available with the County Service Area No. 26 budget (622 180).
