Members of the Board:

Included on today's agenda are the bid openings and contract awards for the repair of several 1998 El Niño storm damage sites. In order to provide appropriations for the local match of these projects funded with disaster assistance funds, it is necessary to accept and appropriate Federal Emergency Management Agency (FEMA) reimbursement funds for repairs completed earlier this year. These sites have approved Damage Survey Reports in the amount of \$432,333. Ten percent of this amount will be retained by FEMA pending final audit.

It is therefore recommended that the Board of Supervisors adopt the attached resolution accepting and appropriating FEMA funds in the amount of \$389,100.
