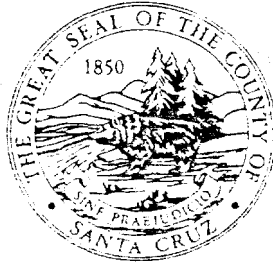

RE: FISCAL YEAR 1998-1999 STATUTORY RAPE VERTICAL PROSECUTION PROGRAM  
 (SRVP) GRANT APPLICATION

Dear Chairperson Beautz and Members of the Board:

We are currently in the process of re-applying to the Office of Criminal Justice Planning (OCJP) to extend and augment our current fiscal year 1998-1999 grant to June 30, 1999. In the upcoming fiscal year, Santa Cruz County is eligible to receive \$150,000 from OCJP to administer the SRVP program. This is the third year that we have received SRVP funding to finance the salary and benefit costs of an Assistant District Attorney and a District Attorney Inspector to investigate and vertically prosecute incidences of unlawful sexual intercourse with a minor as defined in Penal Code Section 261.5. In addition, I am requesting that your Board waive the recovery of indirect overhead charges from OCJP. Staffing and essential services which are required on this program do not leave sufficient funds available for the recovery of indirect overhead costs.

A copy of our grant application will be placed on file for your review with the Clerk of the Board. We will continue to notify your Board of any changes to the fiscal year 1998-1999 SRVP grant extension applications in accordance with applicable County procedures.

THEREFORE, IT IS RECOMMENDED THAT YOUR BOARD

1. Adopt a Resolution authorizing the District Attorney to reapply to the Office of Criminal Justice Planning to extend and augment our fiscal year 1997-1999 Statutory Rape Vertical Prosecution Program grant through fiscal year 1998-1999.

RESOLUTION RATIFYING THE DISTRICT ATTORNEY'S APPLICATION FOR FUNDS DURING FISCAL YEAR 1998-1999 FOR A STATUTORY RAPE VERTICAL PROSECUTION PROGRAM ADMINISTERED BY THE OFFICE OF CRIMINAL JUSTICE PLANNING

WHEREAS, the Board of Supervisors of Santa Cruz County desires to undertake a certain project designated the Statutory Rape Vertical Prosecution Program, to be funded in part from funds made available through the Statutory Rape Vertical Prosecution Program (SRVP) administered by the Office of Criminal Justice Planning (hereafter referred to as OCJP).

NOW, THEREFORE, THE BOARD OF SUPERVISORS RESOLVES AND ORDERS that the District Attorney of the County of Santa Cruz is authorized, on its behalf to submit an application for state funds for a Statutory Rape Vertical Prosecution Program to the Office of Criminal Justice Planning and is authorized to execute on behalf of the Board of Supervisors of Santa Cruz County the attached Grant Award Agreement, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body;

IT IS AGREED that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and OCJP disclaim responsibility for any such liability.


