## ARBOR, INC. CONTRACT FOR ADULT ON-THE-JOB TRAINING (OJT) SERVICES FOR TITLE II-A AND TITLE III PARTICIPANTS

#### Dear Members of the Board:

As you may recall, on May 19, 1998, your Board authorized the Human Resources Agency's CareerWorks Division to conduct contract negotiations with Arbor, Inc. for Adult OJT services for Program Year 1998/99. The contract with Arbor, Inc. will fund brokered job training at employers' worksites for economically disadvantaged adults and dislocated workers. The contract is for \$109,661 of Title IIA funding for 25 participants and \$119,724 of Title III funding for 25 participants for a total of \$229,385 of Federal Department of Labor funds. Funds are available in the Job Training Partnership Act budget for 1998/99; there is no cost to the County. Arbor Inc. was the Title II-A provider for Adult OJT services for the last three years and has consistently exceeded contract service objectives. A copy of the contract is on file with the Clerk of the Board.

### IT IS THEREFORE RECOMMENDED that your Board:

- 1. Approve the contract with Arbor, Inc. for \$229, 385 of which \$109,661 is Title IIA and \$119,724 is Title III funds to provide adult OJT services; and
- 2. Authorize the Human Resources Agency Administrator to sign the contract.
