Members of the Board:

The Board of Supervisors received six bids for the subject projects. MKM General Engineering Contractor was the apparent low bidder at \$130,700. The contractor has notified the Public Works Department that a clerical error was made in MKM's preparation of the bid, and they are requesting that they be allowed to retract the bid.


The second low bid was \$135,180 made by Cimmarron Construction of Oakdale, CA. Cimmarron has verified that its bid is in order. There is sufficient funding in the approved 1998/99 Road Program to cover the additional \$4,480.00 difference between the originally accepted bid of MKM and the bid of Cimmarron.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the retraction of MKM General Engineering Contractor's bid for the Green Valley Road P.M. 6.2, DSR 95056 and P.M. 8.0 DSR 048 Storm Damage Repair Projects.
2. Accept the second low bid of Cimmarron Construction of Oakdale, CA in the amount of \$135,180 and authorize award of the contract.

3. Authorize the Director of Public Works to sign the contract on behalf of the County.


