SUBJECT: POLO GROUNDS COUNTY PARK

Dear Members of the Board:

On June 16, 1998, your Board approved a contract with Dunbar and Craig, a licensed land surveyor, to set grade stakes for the interim development of three ballfields, one soccer field, a second paved parking area, extension of the access road to the second parking area, and the associated drainage improvements at the Polo Grounds County Park in Aptos. This development is being underwritten by a donation from the Monte Foundation.

In June, Dunbar and Craig performed the rough construction staking associated with their agreement with the County. Granite Construction Company, who is partially donating their services to this project, would like to perform the grading work on weekends rather than weekdays. This request is before your Board today as a public hearing to consider such a modification to our existing permits, which would allow grading work to occur on five weekends (Saturday and Sunday) beginning on August 8, 1998. In any case, many of the rough construction stakes installed by Dunbar and Craig in June are now missing. In order to reestablish these grade stakes will require additional field work by Dunbar and Craig in an amount not-to-exceed \$2,500, for a new contact total of \$14,110.

It is therefore RECOMMENDED that your Board:

1. Approve an Amendment in the amount of \$2,500, with Dunbar and Craig to reestablish field staking associated with the development of the three ball diamonds, one soccer field, a second paved parking area, extension of the access road to the second parking area and the affiliated drainage improvements at the Polo Grounds County Park.

2. Authorize the Director of Parks, Open Space and Cultural Services to sign the Amendment on behalf of the County.
