SUBJECT: FREEDOM SUBMERSIBLE PUMP STATION RETROFIT - PHASE 1

Members of the Board:

Included in the proposed 1998/99 Budget are appropriations for improvements at various small pump stations in the District. The existing pumps have reached the end of their useful life and have become increasingly difficult to maintain. The upgrade will eliminate the existing need for confined space entry and reduce maintenance costs. The improvements will also result in more reliable stations, thereby reducing the risk of spills.

The plans, specifications, and estimate have been completed for the subject project, and are presented here for your consideration and approval. The engineer's estimate for this project is \$140,000, including contingencies and administration. Sufficient funds are available for this project.

It is therefore recommended that the Board of Directors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids;
2. Set the bid opening for 10:45 A.M. on August 4, 1998
3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning June 28, 1998, in accordance with the provisions of Public Contract Code Section 20783.
