Members of the Board:

Ordinance No. 13, adopted on June 26, 1984, provided for collection of the District's water and sewer service charges on each year's tax roll until June 30, 1999, pursuant to Section 5473 through 5473.11 of the Health & Safety Code of the State of California. Accordingly, attached herewith is the Notice of Public Hearing fixing the time and place for the annual hearing on the service charge report for water and sewer service charges on property within the Davenport County Sanitation District. Also attached is a copy of the resolution that will be considered by your Board after the public hearing.

The purpose of the hearing is for the Board to hear and consider all objections or protests, if any, to the written report of service charges.

It is therefore recommended that the Board of Directors take the following action:

- 1. Set Tuesday, August 4, 1998, after the morning agenda which begins at 9:00 a.m. as the date and time for a public hearing on the service charge report.
- 2. Direct the Clerk of the Board to publish the attached Notice of Public Hearing at least ten days prior to the hearing in a newspaper of general circulation.

3. Direct the Clerk of the Board to place the attached resolution overruling protests and confirming the report on the August 4, 1998, agenda for Board consideration following the public hearing.

RESOLUTION OVERRULING PROTESTS AND CONFIRMING THE REPORT, ON WATER AND SEWER SERVICE CHARGES FOR FISCAL YEAR 1998/99 ON PROPERTY WITHIN THE DAVENPORT COUNTY SANITATION DISTRICT

RESOLVED, by the Board of Directors of the Davenport County Sanitation District, County of Santa Cruz, California, that:

WHEREAS, this Board did, on June 26, 1984, approve Ordinance No. 13, Providing for the Collection of Service Charges on the Tax Roll, and a written service charge report having been filed on May 4, 1998, with the Clerk of said Board containing a description of each parcel of real property and the amount of the service charges to be collected on the County Tax Roll for each parcel of real property receiving services and facilities from the Davenport County Sanitation District for the 1998/99 fiscal year; and

WHEREAS, this Board appointed the time and place of public hearing on said report and notice was duly given in the manner provided by law as appears by the affidavits of publication on file; and

WHEREAS, said matter came on regularly for hearing at the time and place fixed and all written protests and other communications were publicly read at said meeting and all persons desiring to be heard were fully heard;

NOW, THEREFORE, IT IS DETERMINED AND ORDERED, as follows:

- 1. That objections to and protests against said report were not made by the owners of a majority of the separate parcels of property described in the report.
- 2. That all objections to and protests against said report have been heard by this Board and that said objections and protests be, and each of them is hereby, overruled.
- 3. That said report be, and it is hereby adopted in **full** with any revision and modification pursuant to Health and Safety Code, Section 5473.3, and that the charges as specified in said revised and modified report shall be collected on the tax roll of the County of Santa Cruz, in the manner provided by law.

- 4. That the Clerk of the Board is hereby directed to file with the **County** Auditor of Santa **Cruz** County, on or before the 10th day of August 1998 a copy of said report, upon which shall be endorsed over her signature a statement that the report has been finally adopted by the Board of Directors of the Davenport County Sanitation District, County of Santa Cruz for the 1998/99 fiscal year.
- 5. The County Auditor of Santa **Cruz** County shall, upon receipt of said report, enter the amounts of the charges against the respective lots or parcels as they appear on the assessment roll for the fiscal year.
