### Members of the Board:

The subject project was completed on July 27, 1998. The Contractor was Roger Jones Construction. The original bid amount was \$210,881. Several change orders were processed for a total of \$31,562 to address changes found to be necessary during the course of construction. Due to the unforeseen structural problems, it was necessary to return to your Board on November 4, 1997 to request an increase to the appropriations of \$15,000 as costs were expected to exceed the anticipated costs including the 10% contingency. Total construction cost was \$242,443.

It is therefore RECOMMENDED that your Board take the following action:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$242,443;
- 3) Authorize the Clerk of the Board to file the Notice of Completion, a copy of which is attached;
