ADOPT RESOLUTION TO IMPLEMENT CLASSIFICATION ACTIONS

Dear Members of the Board:

A classification review in the Human Resources Agency recommends consolidation of two classes and abolishment of another. The review recommends consolidation of the classes of Veterans Service Representative II and Senior Veterans Service Representative into one titled Veterans Services Representative, and abolishment of the class of Veterans Services Representative I. The review further recommends that the combined class be placed at the same range CB (\$2297-2876 monthly) as Senior Veterans Service Representative.

There is agreement with HRA and SEIU Local 415 on the proposed classification and salary actions.

It is also recommended that the title for the class of Redevelopment Project Coordinator be changed to Redevelopment Project Manager to reflect practice in other agencies.

It is **RECOMMENDED** that your Board adopt the attached resolution to amend Resolution No. 279-75 to effective the actions described above.
