Patricia J. Manning Historic Resources Commission

My interest in history and historic preservation was actually sparked by my obsession with the study of family history. For the past 15 years I have been traveling "back in time" throughout California and extensively in the **midwest**, the east and our southern states. I have learned how important a knowledge of the history of an area is to understanding the people of past generations.

As I began collecting family photos and other personal effects of my ancestors, I realized how little we have of our past and the importance of carefully preserving what we do have for future generations. I am actively involved in the preservation of photos of people, both those of my ancestors and those of others who lived in their communities.

A fourth generation Californian, I have lived in Aptos for over 20 years. My interest in the history of Santa Cruz County began with my involvement in the community of Valencia and its remaining structures. I am also involved in the planning stages of the development of a living history project to be an integral part of our Valencia Post Office and General Store Museum.

I am interested in serving on the Historic Resources Commission because I am committed to the importance of preserving our local history and those historic structures remaining. I believe my work with the Valencia Hall and Post Office project has given me the framework in which to serve the County of Santa Cruz in this important area.
