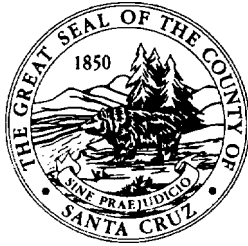

**Members of the Board:**

The plans, specifications, and engineer's estimate for the subject emergency relief project are now complete and presented here for your consideration and approval. The work as approved by the California Department of Transportation (CALTRANS) under the subject Damage Assessment Forms (DAFs), allows for the repair of the slipout at the subject location on Soquel-San Jose Road which resulted from the February 1998 storms. This project will provide for the construction of an under drain system, earth embankment, and road surface repair.


The engineer's estimate for this work is \$95,000.00 including contingencies and overhead. Funding for this project has been made available through the Federal Highway Administration's "On System" road storm repair program which is administered by CALTRANS. Funds for the local share of these expenses are made available within the approved 1998/99 Road Budget program.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 a.m. on September 15, 1998.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning August 16, 1998, in accordance with the provisions of Public Contract Code Section 20392.




The work to be done consists in general of construction of an underdrain system, road drainage facilities, earthwork, road repair, and erosion control measures.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class 'A' license at the time this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
