### Live Oak Swim Center - Settlement Agreement

Dear Members of the Board:

Construction of the Simpkins Family Swim Center and Live Oak Community Center is near completion, with the opening of the facility anticipated for this fall. Indoor and outdoor finishes are being completed, including final plastering of the pools, the landscaping is being installed, and purchase of furniture and supplies for the pool, community room, and office areas has been initiated. In order to move forward with various aspects of project completion, several actions need to be taken by your Board at this time.

The Agency, Parks Department, and the Pool of Dreams are in the process of identifying and ordering pool equipment for competitive events. These items will be financed through the Pool of Dreams fundraising efforts. Since we last reported to your Board on this matter, the Pool of Dreams has raised an additional \$8,140 for equipment which is now in their Trust Fund. In order to expend these funds, it is necessary to accept and appropriate the \$8,140 as provided for in Attachment 1.

An additional issue that needs to be addressed as we near the end of the project is the payment for a settlement agreement between the Agency and Paul T. Beck Contractors, the grading subcontractor who was **onsite** during the early stages of the project. Earlier this year, that agreement was approved by your Board, providing for payment by the Agency to the subcontractor in the amount of \$65,000 for activities related to earthwork. In order to provide the necessary payment, it is appropriate at this time to transfer \$42,268 from the Agency's Capital Projects Bond Proceeds Reserves along with \$22,732 in interest that has accrued to the Trust Fund to the project budget, per Attachment 1.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, approve the attached Resolution Accepting and Appropriating Unanticipated Revenue totaling \$73,140 (Attachment 1) to the swim center project budget.
