## SUBJECT: MUIR DRIVE OVERLAY COUNTY SERVICE AREA NO. 26, HIDDEN VALLEY ROAD AWARD OF CONTRACT (1 ST DISTRICT)

Members of the Board:

On August 4, 1998, the Board of Supervisors received three bids for the Muir Drive Overlay, County Service Area No. 26, Hidden Valley Road. The engineer's estimate was \$33,437.50. The low bidder was Earthworks of Santa Cruz, California in the amount of \$33,985.00 for a total contract cost of \$37,968.95 including contingencies and overhead. Sufficient funds are available in the County Service Area No. 26 budget (622180) to cover this expenditure.

- It is therefore recommended that the Board of Supervisors take the following action:
- 1. Accept the low bid of Earthworks in the amount of \$33,985.00 and authorize award of the contract.
- 2. Authorize the Director of Public Works to sign the contract on behalf of the county.
