Members of the Board:

At the August 4, 1998 Board meeting, bids were received for the Valencia Hall Drainage project. That letter incorrectly referenced Measure E funds; this project is being funded through Aptos Park Dedication Funds. Your Board directed the Parks, Open Spaces and Cultural Services Department and the General Services Department to review bids and return on or before August 25, 1998 with a recommendation for award. As directed, bids received have been reviewed and we believe that the lowest bidder, Johnson and Company with a bid of \$52,350, can accomplish the work to the County's satisfaction.

Sufficient funds are available in the Parks, Open Space and Cultural Services Budget for this project including a 10% contingency.

It is therefore RECOMMENDED that your Board:

- 1. Award a contract to Johnson and Company in the amount of \$52, 250; and
- 2. Direct General Services to notify the Contractor and arrange for completion of contract documents; and
- 3. Authorize the Director of Parks, Open Space and Cultural Services to approve change orders, if required, up to \$5,235; and

- 4. Appropriate \$5,235 in addition to the contract amount to cover change order expenditures, if required; and
