**Proposed Ordinance Amending Sections 2.106.020 and 2.106.030
Relating to the County Disaster Council Ordinance**

Dear Members of the Board:

The purpose of today's report is to submit a proposed amendment to the County Disaster Council Ordinance to include the County Planning Director as an additional member of the Council. This proposed amendment was discussed and recommended by the County Disaster Council at a regular meeting earlier this year. It will facilitate the Council's understanding of ongoing mitigation and recovery actions taken by the Planning Department in addressing the local impact of natural disasters. Additional format changes to the chapter's subsections are being proposed by County Counsel for facilitating the reading of the chapter itself and to accommodate the change in the title of the Deputy Director of General Services.

It is therefore recommended that your Board:

1. Accept the attached proposed ordinance in concept; and
2. Direct the Clerk to publish the attached Notice of Intention to Adopt Ordinance summarizing the proposed ordinance; and
3. Direct the proposed ordinance be returned to the Board for final consideration on September 22, 1998.

**ORDINANCE AMENDING SECTION 2.106.020
TO THE SANTA CRUZ COUNTY CODE RELATING TO
DISASTER COUNCIL MEMBERSHIP
AND SECTION 2.106.030 RELATING TO
TERM OF OFFICE**

The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION I

The Santa Cruz County Code Sections 2.206030 and 2.106.020 are hereby amended by adding an additional member and subsection 2.106.020 A. is renumbered to read as follows:

2.106.020 Membership.

The disaster council shall consist of the following members:

- A. ~~The following individuals or designees:~~
 - ~~A.1. Deputy Director of Emergency Services General Services of the County, or his/her designee;~~
 - ~~B. 2. Emergency Services Coordinator;~~
 - ~~C. 2. Sheriff-Coroner of the County, or his/her designee;~~
 - ~~D. 3. Public Works Director of the County, or his/her designee;~~
 - ~~E. 4. Planning Director of the County, or his/her designee;~~
 - ~~F. 5. Area Fire Coordinator of the Fire Chiefs Association, or his/her designee;~~
 - ~~F. 6. A representative of the County’s emergency medical services program, designated by the Health Services Administrator.~~

~~G.B.~~ Representatives of the following agencies, as appointed by the Board of Supervisors upon nomination by such agencies:

1. California Highway Patrol;
2. CAL TRANS;
3. Pacific Gas and Electric;
4. University of California, Santa Cruz Campus;
5. Amateur Radio (ARES);
6. Local Red Cross;
7. Pacific Bell Telephone;
8. Emergency Broadcasting System carrier for Santa Cruz County;
9. Each incorporated city's designated OES coordinator;
10. Santa Cruz Metropolitan Transit District;
11. Voluntary Agencies Active in Disaster (VOAD);
12. Water Agencies Task Force;
13. County Office of Education.

H.C. Five residents of the County, appointed by the Board of Supervisors. Each supervisor shall nominate one member who may reside within the supervisor's district, and who has some knowledge of, or involvement with, one or more organizations having some official responsibility in the event of an emergency, and

H.D. At large community member, who represents a local volunteer effort related to disaster planning. This member shall be appointed by the Board of Supervisors upon nomination by the Director of Emergency Services.

2.106.030 Term of office.

A member appointed pursuant to the provisions of Section 2.106.020 A. ~~through G. and B.~~ shall serve on the disaster council ex officio, as long as such member continues to hold the office or appointment which initially qualified him or her for membership. The members of the disaster council appointed pursuant to the provisions of Section 2.106.020 **H.C.** shall serve for a term of four years, commencing on April 1st of the year in which the member's nominating supervisor begins a full term. The member appointed pursuant to Section 2.106.020 **H.D.** shall serve for a term of two years, commencing on January 1st of the calendar year in which initial appointment is made.

SECTION II

This ordinance shall take effect on the 3 1st day after the date of final passage.



The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION I

The Santa Cruz County Code Sections 2.106.030 and 2.106.020 are hereby amended by adding an additional member and subsection 2.106.020 A. is renumbered to read as follows:

2.106.020 Membership.

The disaster council shall consist of the following members:

A. The following individuals or designees:

1. Deputy Director of General Services of the County, or his/her designee;
2. Sheriff-Coroner of the County, or his/her designee;
3. Public Works Director of the County, or his/her designee;
4. Planning Director of the County, or his/her designee;
5. Area Fire Coordinator of the Fire Chiefs Association, or his/her designee;
6. A representative of the County emergency medical services program, designated by the Health Services Administrator.

B. Representatives of the following agencies, as appointed by the Board of Supervisors upon nomination by such agencies:

2.106.030 Term of office.

A member appointed pursuant to the provisions of Section 2.106.020 A. and B. shall serve on the disaster council ex officio, as long as such member continues to hold the office or appointment which initially qualified him or her for membership. The members of the disaster council appointed pursuant to the provisions of Section 2.106.020 C. shall serve for a term of four years, commencing on April 1st of the year in which the member's nominating supervisor begins a full term. The member appointed pursuant to Section 2.106.020 D. shall serve for a term of two years, commencing on January 1st of the calendar year in which initial appointment is made.
