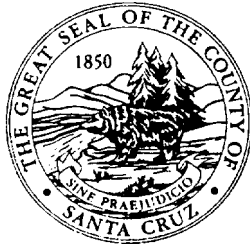

SUBJECT: EUREKA CANYON ROAD PM 1.65 TO 4.75 AND
LITCHFIELD LANE FEMA STORM DAMAGE REPAIR

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work will provide for the accumulative storm damage repair of eight locations along Eureka Canyon Road and a single location on Litchfield Road at Green Valley Road. All sites are damages from storms as far back as 1996. Public Works will repair these road damages and provide by the contract forces some minor ditch cleaning along the road in the area of each storm site to mitigate surface drainage difficulties during the winter of 1998/99.


The engineer's estimate for this work is approximately \$290,000.00 including contingencies and overhead. Sufficient funding for this project has been made available by the approved 1998/99 Road Program (DSR and Operational Maintenance funds).

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids.
2. Set the bid opening for 10:45 AM on September 1, 1998.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning August 15, 1998, in accordance with the provisions of Public Contract Code Section 20392.



Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., September 1, 1998 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisor's Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on the referenced Public Works project in accordance with the specifications therefor, to which special reference is made, as follows:

STORM DAMAGE REPAIR

The work to be done consists in general of construction of rock slope protection, earthwork, road repair, drainage facilities and erosion control measures.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class 'A' license at the time this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
