Resolution Accepting and Appropriating Unanticipated Revenue from Pajaro Valley Prevention and Student Assistance, Inc. for Gang, Crime & Violence Prevention Partnership Grant

Dear Board Members:

On August 4, 1998, your Board approved the Probation Department's participation in the Office of the State Attorney General's California Gang, Crime and Violence Prevention Initiative Proposal, submitted by Pajaro Valley Prevention and Student Assistance, Inc. (PVPSA). PVPSA was recently notified by the State Attorney General's Office that their proposal was accepted and that formal notification of the grant award, retroactive to July 1, 1998, is forthcoming.

This two-year grant funded program, officially titled as the "Esperanza Project to Prevent Gangs, Crime and Violence in the Pajaro Valley" includes a truancy program to be staffed by the Probation Department with one full-time, bilingual Probation Officer II. The Probation Officer, along with a half-time counselor position, will provide services to youth and their families who have chronic truancy and/or behavioral problems at three middle school sites. Prevention services will be designed to target youth who are at the highest risk of entering the juvenile justice system. This program is viewed as an opportunity for the Probation Department, in partnership with PVPSA, to identify and intervene in the lives of high risk youth at an early stage.

Salary costs for the Probation Officer II and related service and supply expenditures are fully funded by this grant award, and will be reimbursed though quarterly invoices to PVPSA. There is no increase in net county cost as a result of the Probation Department's participation in this collaborative program.

IT IS THEREFORE RECOMMENDED that your Board:

1) Adopt the attached resolution accepting unanticipated revenue in the amount of \$56,000 from Pajaro Valley Prevention and Student Assistance, Inc., and appropriate these funds for costs associated with the Probation Department's participation in the Esperanza Project as described in the attached AUD-60; and

 - 2) Add 1 .O full-time, limited term (through June 30, 2000) Deputy Probation Officer II position to Probation Department (Index 574100) and direct the Personnel Department to study and classify the position.
