Dear Members of the Board:

Appointments In-Lieu of Election

Attached are resolutions calling for the appointment of unopposed Special District candidates who filed Declarations of Candidacy with the Elections Department.

Due to an insufficient number of candidates, the Special Districts will not appear on the November 3, 1998 Consolidated General Election ballot.

Pursuant to Elections Code Section 10515, the Board of Supervisors is required to make appointments prior to Monday, November 30 at a regular or special meeting of your Board. Candidates to be appointed are listed in Attachment A.

<u>Appointments to Fill Vacancies</u>

Also, pursuant to Elections Code Section 10515 the Board of Supervisors is required to appoint qualified persons to fill the vacant positions on the Special District boards for which no one filed. The vacancies that need to be filled by November 3, 1998 are contained in Attachment B. I have notified the special districts of the existing vacancies and have provided them with a notice to be posted and applications for interested persons. Applications will be forwarded to your Board for appointment.

Santa Cruz Resource Conservation District Filled by Appointment Only

As you may recall, members of the Santa Cruz County Resource Conservation District are now appointed instead of elected pursuant to resolution No. 96-05-01 adopted by the Resource Conservation District on May 2, 1996 and accepted by your Board on June 11, 1996. Appointments to the Resource Conservation District Board must also be made by November 3, 1998.

School District Board Appointments — FYI

For your information, I have, also provided a list of candidates who will be appointed in-lieu of election to school districts by their respective school district governing board. Your Board is not required to take any action in regards to appointing school district governing board members. See Attachment C for a list of persons appointed in-lieu of election to school district boards.
