RE: DISTRICT ATTORNEYS FISCAL YEAR 1998-1999 STATE DEPARTMENT OF INSURANCE AUTOMOBILE INSURANCE FRAUD AND WORKERS' COMPENSATION INSURANCE FRAUD PROGRAMS

Dear Chairperson Beautz and Members of the Board:

This is to request your Board's authorization to reapply to the State Department of Insurance for \$166,662 in FY 1998-1999 funding to support the efforts of this office in the investigation and prosecution of Automobile Insurance Fraud and Workers' Compensation Insurance Fraud cases. The receipt of these insurance fraud funds and the expenditure of said funds for program purposes were anticipated and approved in the county budget for FY 1998-1999.

The statutory authority authorizing the Department of Insurance to provide funding for Automobile Insurance Fraud investigations and prosecutions is contained in California Insurance Code Section 1872.8, California Code of Regulations Subchapter 9, Article 4, Section 2698.65. The statutory authority authorizing the Department of Insurance to provide funding for Workers' Compensation Insurance Fraud investigations and prosecutions is contained in SB 1218 (Chapter 116), Statutes of 1991.

As part of the reapplication process, we are requesting that your Board approve the attached Resolutions authorizing our reapplication to participate in the insurance fraud programs. The form of these Resolutions is very similar to the Resolutions approved by your Board in previous fiscal years.
