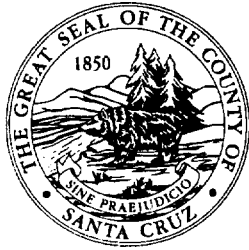

SUBJECT: SAN VICENTE CREEK STREAM BANK PROTECTION PROJECT

Members of the Board:

The plans and specifications for the subject project are complete and presented here for your consideration and approval. The project will provide for rock slope protection along an eroded section of San Vicente Creek in the town of Davenport.

The United States Department of Agriculture Natural Resources Conservation Service (NRCS) has estimated the construction cost to be \$160,000 and will fund 75 percent of this (\$120,000) plus 8.5 percent (\$13,600) for engineering and inspection. The State Office of Emergency Services (OES) has indicated that they will prepare a Damage Survey Report for 75 percent of the eligible local costs. The remaining portion of the local share will be funded by the Santa Cruz County Flood Control and Water Conservation District, Zone 4 and the homeowners benefitting from the project.

The total project cost including surveying, engineering, construction, inspection, and administration is estimated to be \$195,000, of which \$133,600 will be funded by the NRCS, \$37,700 by OES, \$16,200 by Zone 4, and \$7,500 by the homeowners.

It is therefore recommended that the Board of Supervisors take the following action


1. Approve the plans, specifications, and estimate and authorize calling for bids.
2. Set the bid opening date for October 6, 1998 at 10:45 a.m.



The work to be done consists in general of slope protection and replanting within the riparian corridor as shown on the plans and described in these special provisions.



The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
