Dear Board of Supervisors:

David Herrlich has retained the services of the Law Offices of Frances P. Henderson for filing a claim for false arrest, and imprisonment, and the consequent pain and suffering he experienced on March 26, 1998 through March 31, 1998, in Santa Cruz County iail. His claim is as follows:

Herrlich was stopped while on his bicycle near the Mr. intersection of Freedom Boulevard and Marin Street in the City of Watsonville on March 26, 1998, by an officer of the Watsonville Police Department. After checking Mr. Herrlich's license, the officer left and returned approximately, the minutes later accompanied at least six other officers. They advised Mr. Herrlich that there was a "no-bail" felony warrant outstanding, handcuffed him and arrested him. He was taken to Santa Cruz County jail. Mr. Herrlich told the Watsonville Police officers that his last and only criminal charge occurred in the late 1980's and his probation (for possession of a controlled substance) had terminated four years prior to the date of his arrest. He repeated this to the Santa Cruz County Sheriff Department. Neither agency investigated Mr. Herrlich's representations, and Mr. Herrlich was held in custody.

On March 27, 1998, I contacted the clerk of the Municipal Court, criminal department, in an attempt to obtain Mr. Herrlich's release, but was notified that he was "no-bail" status because of an allegation he had absconded from the County. I attempted to review the file, but it was in storage and would not be available until the following week.

At his arraignment on March 30, 1998, Mr. Herrlich advised that he was represented by counsel, and Judge Michael Barton advised him to remain silent until he spoke with his attorney and set a hearing for the next day for further arraignment. set a hearing for the next day for further arraignment. On March 31, 1998, Probation Officer Andy Azevedo recommended Mr. Herrlich receive 6 months in county jail.

After representing to the Court that Mr. Herrlich believed that his probation had terminated, he was released on his own recognizance pending the next hearing date of April 23, 1998. On that date the Court was closed due to a fire in the basement and Mr. Herrlich returned to court on April 30, 1998. At this time it was confirmed that his probation had indeed terminated prior to his arrest, and his case was dismissed.

Mr. Herrlich was damaged as follows:

Enclosed herewith is a copy of the Attorneys' Fees Statement of April 1998; Mr. Herrrlich is employed at the rate of \$25.00 per hour as a property manager for 40 hours per week, and he was so employed at that time.

Mr. Herrlich was arrested without any cause whatsoever and was negligently held on this erroneous charge. He spent five days in jail because of an error on the part of the County of Santa Cruz. He was humiliated and his physical safety was put at risk. He seeks recovery  $\mathbf{f} \circ \mathbf{r}$  the shame and umiliation as well as the special damages itemized above. Consequently, Mr. Herrlich 'herein presents a claim of \$25,750 against the County of Santa Cruz.
