The Board of Supervisors received five bids for the subject project on September 15, 1998. The engineer's estimate for this storm repair project was \$629,435. The low bid for the work was submitted by On-Grade Contracting of Jamestown, California in the amount of \$681,693. All bids were checked and found to be in order.

Funding for the project is made available by the approved 1998/99 Road Program.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of On-Grade Contracting in the amount of \$681,693 and award the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the County.
