BEACH ROAD REHABILITATION PROJECT SUBJECT:

SAN ANDREAS ROAD TO PAJARO DUNES

Members of the Board:

The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for pavement rehabilitation of a portion of Beach Road between San Andreas Road and Pajaro Dunes. The rehabilitation work will allow for the dig out and replacement of various pavement locations along the roadway. After this work is complete it would be our intention to include this portion of Beach Road in the 1999 chip seal program.

The engineer's estimate for this combined work is \$140,000, including contingencies. Funding for this project has been made available by the approved 1998/99 Road Program.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the Beach Road Rehabilitation Project.
- 2. Set the bid opening for 10:45 a.m. on October 20, 1998.
- 3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning September 26, 1998, in accordance with the provisions of Public Contract Code Section 20392.
