SUBJECT: RESCHEDULE A PUBLIC HEARING TO CONSIDER APPLICATION 95-0685 (BAILEYISTELTENPOHL)

Members of the Board:

On May 13, 1998 the County Planning Commission referred Application 95-0685 to your Board with a recommendation to approve the project. This project, located on the coastal side of Highway 1 in Davenport, includes a proposed rezoning. The rezoning makes this a Level 7 project which requires action by your Board for approval. The Planning Commission also directed staff to investigate with Caltrans methods for improved pedestrian safety at the Davenport segment of Highway 1 before bringing this project to your Board for consideration. Caltrans has now conducted their field work at the project vicinity and has provided County Planning with a final report on their recommendations.

Your Board has scheduled a public hearing for this project for October 6, 1998. However, it has been brought to my attention that one member of the Board is scheduled to be in attendance at a National Transportation Meeting and will therefore be unable to attend the Board meeting. I believe it would be in the public's interest to reschedule the hearing for the next Board meeting after October 6 so that the full Board is available for consideration of this item. My staff has contacted the applicants and they will be able to attend a hearing scheduled for October 20. Our Board is not scheduled to meet on October 13.

It is therefore RECOMMENDED that your Board schedule October 20, 1998 at 1:30 p.m. to consider the Planning Commission's recommendation on Application 95-0685.
