The plans, specifications, and engineer's estimate for the subject project are now complete and presented here for your consideration and approval. The work provides for a two-inch overlay of Viewpoint Drive, County Service Area No. 25, (2nd District).

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., September 22, 1998 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for an asphalt concrete overlay on Viewpoint Drive in accordance with the specifications therefor, to which special reference is made, as follows:

VIEWPOINT DRIVE OVERLAY -PROJECT

The work to be done consists, in general, of reconstructing portions of the existing roadway pavement and applying a 2 inch pavement overlay over pavement fabric to the limits indicated on the plans.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
