**Adopt Resolution to amend the Salary Resolution to establish the new class of Water Resources Program Manager**

Dear Members of the Board:

A classification study has been completed regarding a new position in the Planning Department which will report directly to the Planning Director and will be responsible for coordination of the County's Water Resources Management activities related to promoting the efficient use of water resources; identifying effective strategies for developing sustainable long-term water supplies; and establishing a coordinated framework for ongoing implementation of water resources protection measures.

The Water Resources Manager may have supervisory responsibility and will work with local water districts, regional water agencies and interest groups to implement the Board's policies. It is recommended that this position be classified as the Water Resources Manager in the Middle Management Unit and placed at salary range D7 (23.45-31.26).

IT IS THEREFORE RECOMMENDED that your Board adopt the attached Resolution to amend Resolution No. 279-75 to adopt the actions described above.


