### Statement of Oualifications

I am interested in serving on the Santa Cruz County Child Care Planning Council in order to represent the County Human Resources Agency, and to provide additional support for consideration of the needs of the families served by the Human Resources Agency in child care planning and policy development.

I believe that I am qualified to serve on the Planning Council because of my background and experience with child care from a number of different perspectives. My primary qualifications are my assignments with the Human Resources Agency to work with Child Care Program on administrative issues, and to administer the County Child Care Fees Loans Program. My earliest experience with child care needs was advocacy for a child care center for staff and students at the University of California at Students, including the organization of a "child-in" which led to the establishment of the first child-fare center at that campus. Later, while I served on the Board of Directors of the Santa Cruz YWCA, I helped to develop the site plan and funding strategy for the child care center at the Walnut Avenue site. In addition, as a project manager for the Redevelopment Agency, I worked on several affordable housing projects which have included or are proposed to include child care centers as a part of the project. Finally, over the past fifteen years, I have also had direct personal experience as a parent with a broad range of child care providers and programs.
