DR-1203 EL NIÑO 1998 WINTER STORMS


Members of the Board:

During the February 1998 winter storms, several County Service Areas (CSAs) sustained damages to their roads as a result of heavy rains. At the request of service area representatives, Public Works applied for and received disaster assistance funding from the Federal Emergency Management Agency (FEMA) and the California Office of Emergency Services (OES). Funding has been received for debris removal and protective measures which have already been performed. Advance monies have also been received for permanent repairs that have not yet been completed.

As the 1998/99 CSA budgets did not include line items for revenue received from FEMA or OES, we are requesting that your Board adopt a resolution accepting unanticipated revenue so that the CSAs may continue with completing repairs to roads.


It is therefore recommended that the Board of Supervisors adopt the attached resolution accepting unanticipated revenues in the amount of \$306,299 for various County Service Areas.

RESOLUTION ACCEPTING UNANTICIPATED REVENUE

WHEREAS, the County of Santa Cruz is a recipient of funds from the Federal Emergency Management Agency and the California Office of Emergency Services for County Service Area storm repair programs; and

WHEREAS, the County is a recipient of funds in the amount of \$306,299 which are either in excess of those anticipated or are not specifically set forth in the current fiscal year budget of the County; and

WHEREAS, pursuant to Government Code Sections 29 130(c), 29064(b), such funds may be made available for specific appropriation by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Santa Cruz County Auditor-Controller accept funds in the amount of \$306,299 into Public Works Department County Service Areas.




