Forty-First Avenue and Hook Parking Lot Improvement Project

Dear Members of the Board:

The Forty-First Avenue and Hook Parking Lot Improvement Project, which provides for road, drainage, utility, streetscape and parking lot improvements is now under construction with completion anticipated in mid-November.

As described in the letter from Public Works on this agenda, construction of the project resulted in the need for additional excavation and aggregate base in the parking lot, and additional trench paving on Forty-First Avenue. In order to provide funding for this work and additional work anticipated to complete the project it is necessary to transfer funds totaling \$10,000.00, including overhead, from the Agency's Capital Projects Bond Proceeds Reserves to this project. The funds are available for this purpose.

Redevelopment Agency staff has determined that improvements associated with the Forty-First Avenue and Hook Parking Lot Improvement Project are of benefit to the Project Area, that no other reasonable means of financing the improvements are available to the community, that the project will assist in the elimination of blight, and the project is consistent with the Redevelopment Agency's Five Year Plan.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, take the following actions:

- Approve Agency funds totaling \$10,000.00 for the Forty-First Avenue and Hook 1. Parking Lot Improvement Project;
- 2. Approve the attached Resolution Accepting Unanticipated Revenue totaling \$1 O,OOO.OO from the Redevelopment Agency's Capital Projects Bonds Proceeds Reserves: and
- Concur with and adopt the associated findings. 3.
