

On January 1, 1995, Director Hinkle was appointed by the Santa Cruz County Board of Supervisors to serve a four year term on the Board of Directors of the Santa Cruz Metropolitan Transit District. Director Hinkle's term expires on December 31, 1998.

On September 18, 1998, Michael Keogh was appointed to serve the remainder of a four-year term as one of the County's at-large representatives on the Board of Directors of the Santa Cruz Metropolitan Transit District.
