AMENDED COUNTY RESOLUTIONS

Members of the Board:

Attached are copies of Program Supplements No. 006-M (Bridge Seismic Retrofit Program) and 010-M (Emergency El Niño Storm Relief) to County-State Agreement No. 05-5936. Both these Program Supplements had already been approved by your Board and delivered to CALTRANS by the Clerk of the Board. CALTRANS has now requested that they be resubmitted with certain corrections and revisions. Neither of these changes would affect the amount of funding that the County will receive.

Program Supplement No. 006-M was originally authorized in October of 1997, and allows Public Works to request seismic retrofit preliminary engineering expense reimbursement from the state. CALTRANS has requested that the County also allow for a reimbursement of <u>all County overhead charges</u> expended from June 30, 1998, to present (see attached special covenant page, in duplicate). To allow for this additional reimbursement, we request that the Board adopt the attached Resolution Amending Resolution No. 396-97 authorizing Program Supplement No. 006-M and authorize the Director of Public Works to sign the Special Covenant Amendment.

Program Supplement Number 0 1 O-M (Emergency El Niño Storm Relief) was originally approved by your Board in September of this year. CALTRANS has since informed Public Works that the original resolution, which authorized reimbursement of <u>all</u> County expenses related to the 1998 "On-System" road repairs at various county-wide locations, was in error. Apparently, the original resolution incorrectly stated that reimbursement for one group of the El Niño Storm Damage Assessment Forms (DAFs administered by Federal Highways) would be in part from State exchange funds. In order to correct this error, CALTRANS has requested we forward them a copy of the Resolution Amending Resolution No. 373-98, authorizing Program Supplement No. 010-M.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Adopt the attached Resolution Amending Resolution No. 396-97 authorizing Program Supplement No. 006-M agreement between the State of California and the County of Santa Cruz for **funding** preliminary engineering and overhead expenses for the work accomplished **after** June 30, 1998, for work on the Bridge Seismic Retrofit Program.
- 2. Authorize the Director of Public Works to sign the Special Covenant Amendment (and duplicate amendment) to Program Supplement No. 006-M for the State reimbursement of County overhead charges.
- 3. Adopt the attached Resolution Amending Resolution No. 373-98 authorizing Program Supplement No. 0 1 O-M agreement between the State of California and the County of Santa Cruz allowing for the reimbursement of County expenses for the repair of various county wide "On-System" road storm damage.
- 4. Direct the Clerk of the Board to return the Special Covenant Amendment along with one certified copy of the authorizing resolution to Program Supplement No. 006-M and one certified copy of the authorizing resolution to Program Supplement No. 010-M to the Department of Public Works.
