On October 20, 1998, your Board authorized the Chief Probation Officer to submit a grant application in the amount of \$32,000 to the California Board of Corrections for the purpose of hiring a consultant to assist in the update of the Local Action Plan and Implementation Grant Proposal. A copy of that Board letter is attached for your information. We are pleased to inform your Board that the grant application was approved. It is now necessary to accept and appropriate the \$15,000 received by the Probation Department.
