## Unified Fee Schedule

Dear Members of the Board:

Attached are the proposed revisions to the Unified Fee Schedule from various County departments. The revisions are accompanied by fee information sheets that provide an explanation of the fee changes.

The Health Services Agency recommends a new Environmental Health fee related to the review of water well permit applications.

The Parks, Open Space, and Cultural Services Department, in an effort to simplify and organize the department's recreation fees, recommends the revision of a number of current fees, the addition of new fees for the Simpkins Family Swim Center, and some minor revisions to the facility reservation section.

The Planning Department recommends identifying specific fees in the Other Charges category which currently are charged at the cost to the Department for providing these services.

The Sheriff recommends the addition of a rescheduling fee for the Work Release Program. Additional information on this recommendation is provided in memo from the department.

IT IS THEREFORE RECOMMENDED THAT YOUR BOARD hold a public hearing on the proposed amendments to the Unified Fee Schedule and adopt the attached resolution revising the Unified Fee Schedule with the amended fees and charges as presented.
